The option vests if the Company's stock price achieves certain targets within specified timeframes as follows: one-fourth shall vest if Fair Market Value of the Company's stock achieves \$49.34, but not earlier than 1/8/07; one-fourth shall vest if Fair Market Value of the Company's stock achieves \$52.86, but not earlier than 1/8/08; one-fourth shall vest if the Fair Market Value of the Company's stock achieves \$57.27 but not earlier than 1/8/09; and one-fourth shall vest if the Fair Market Value of the Company's stock achieves \$61.67 but not earlier than 1/8/10. All options not otherwise vesting pursuant to the above timetable shall become exercisable on July 11, 2011.
